As per rule 3(7) of Fly Ash Act,1999, we are hereby submitting the annual compliance report for fly ashSub.: **Annual Compliance report of Fly Ash as per rule 3(7) of Fly Ash Notification for the period April 2023 to March 2024.**

1. Coal or Lignite based thermal power stations shall achieve the target of fly ash utilization as per schedule given in notification i.e. 100% utilization of Fly ash.

3. As per rule 2(4) of Fly ash notification coal or lignite based TPP/PPP/Co-generation plant shall constitute a dispute settlement committee.

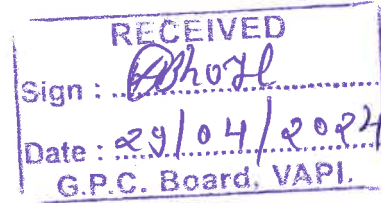
